- Creating External Assessments from Industry Template to send to customers
- Creating Assessments as custom controls by import to send to customers
- Sending Assessments via Trust Network
- Completing Assessments from customer instance. Answering questions, adding evidence, making notes, leveraging chat etc.
- Download Platform Templates from Assessment questions to remediate any identified gaps
- Reviewing evidence as "requester"
- Crosswalking between security frameworks
